#### Opening of the Prague European Summit 2023

#### 18.00 - 19.15 Panel Discussion: European Unity Facing the War

The European Union has responded effectively and in a united fashion to the war of invasion launched by Russia in Ukraine on 24 February 2022. Although there are dissenting voices among the Member States, support for Ukraine has arown steadilu, and European political leaders regularly reaffirm their enduring commitment to the country's independence. However, the upheavals caused by the return of war to Europe are immense, and the Union must face up to multiple challenges in terms of security, economics, energy, geopolitics, etc. Current events in the Middle East are obviously reshuffling the cards of the international order and calling into question the European Union's place in the global balance and its foundations and values. In this period of great instability, is the European project running the risk of cracking? Could citizens become even more distracted from the issues of solidarity and cohesion that are the hallmark of the Union? What unity can be preserved - and how – as a new period of enlargement opens up to new countries?

#### 19.15 – 20.30 Panel Discussion: Reconnecting Narratives in Europe

What kind of Europe are we talking about when we are in Vilnius, Athens, Belgrade, Amsterdam or Kyiv? What are the historical figures, the shared narratives, the architectural ensembles, the squares that we invoke to refer to European roots and a European future? So where is Europe? Does it tell its own story through its relationship with peace, its cultural heritage, the mobility it offers, its economic integration or its technical networks? While these questions are not new, the outbreak of war in Ukraine has highlighted major differences in perceptions of the relationship with the eastern neighbourhood and, by extension, a lack of understanding of the local contexts in which the relationship with Europe and its historical foundations are expressed. So how can we encourage a better circulation of narratives in Europe

while at the same time understanding the concerns and tensions that arise here and there? How can we explain a Europe that is 'growing', possibly to be enlarged in the future to include new countries, when the temptation is to withdraw? What role can geopolitical experts and research professionals play in facilitating discussion and debate on this subject?

# 15:10 – 16:25 Plenary Panel Discussion: Re-invigorating the EU's Neighbourhood Policy and Diplomatic Efforts amid the War in Ukraine

In light of the ongoing war in Ukraine, the European Union's Neighbourhood Policy and diplomatic engagements are under an intense microscope. The intricate web of relations between the EU and its neighbouring countries presents both challenges and opportunities. Beyond the borders of the Union, initiatives such as the European Political Community seek to foster greater cooperation. The post-Brexit era heralds a new chapter in the EU-UK relations, with all its complexities and imperatives. Additionally, the aftermath of the May 2024 elections in Turkey suggests a continuation of the status quo in EU-Turkey ties. Beyond these bilateral and multilateral relations, the EU's role in regional conflicts, including the enduring tensions in the EU's neighbourhood, adds another layer to the discussion. How does the EU's Neighbourhood Policu reflect these developments? What are the primary objectives and potential outcomes of initiatives like the European Political Community, and how do they contribute to fostering greater cooperation between the EU and its neighbouring countries?
